Quotations for the procurement of Grant's Zebra

1. Details of animals to be procured

Pune Municipal Corporation wants to procure Grant's Zebra (1:1) for Rajiv Gandhi Zoological Park & Wildlife Research Centre, Katraj, Pune from foreign Zoo's, animal breeders in the form of donation, gift, disposal of surplus animal, exchange of animals etc. The animals will not be purchased, rather the cost incurring on animal crating, veterinary intervention, handling of animals, transportation, etc. only will be borne by Pune Municipal Corporation. Quotations are requested from authorized interested and experienced wild animal dealers /reputed firms/companies/ wild animal breeders abroad or from within India for providing Grant's Zebra (1:1) i.e. male 1 no. and female 1 no. to Rajiv Gandhi Zoological Park & Wildlife Research Centre, Katraj, Pune. For this quotations are requested for the further administrative procedure with following terms and conditions.

1. Terms & Conditions:

- Pune Municipal Corporation will pay the expenses only for transportation, crating, veterinary care, handling of Zebras etc. The price value of animals will not be paid.
- The animals selected for import must be physically, behaviorally and genetically healthy. All the animals must be free of any underlying or clinical infectious or noninfectious disease condition or stereotypies.
- Animals identified for transport should be from proven genetic pedigree and all individuals should be genetically heterozygous which would further allow the breeding among these animals on scientific lines.
- All the animals required to be of suitable age. The very young and old animals shall not be selected for the import. The animals should be completely weaned off and not dependent on their mother/handlers for food.
- The details in respect of all animals selected for import must be provided which includes details of animals such as date of birth/ estimated age/feed chart, preventative disease management protocol, healthcare history etc.

- vi. Due screening of all the animals selected for the import must be carried out against infectious, contagious and zoonotic diseases prior to its transportation from the donor Zoo. The animals must be regularly immunized against the common diseases prevalent in the species. Every details pertains to immunization, deworming and treatment records must be furnished
- vii. Health certificate of animal fitness for each animal must be issued by Authorized veterinarian.
- viii. Supplier have to strictly follow all Indian and international rules and regulations necessary for the international transport of animals.
- ix. The guidelines of Central Zoo authority of India for the transport of captive wild animals should have got strictly followed.
- x. Supplier should avail the services of Registered custom house agent (CHA) for facilitating the airport quarantine, CITES and customs clearance.
- xi. Supplier will obtain all clearances and NOC's from the respective organizations mandated under Indian and International laws required for the transport of animals from the donor country to India.
- xii. Payment terms:-
 - a) The payment will be made only after receiving the healthy animals as mentioned at Rajiv Gandhi Zoological Park and Wildlife Research Centre Katraj and after the confirmation from the zoo administration.
 - b) Any tax levied by law, such as GST and such other taxes contingent on the Services rendered by the tenderer, shall be payable by the client over and above the professional fee payable to the bidder.

2. Eligibility Criteria

The Suppliers in their own name should have satisfactorily executed the work of similar nature across Zoos in India and abroad during last Ten (10) years ending last day of month previous to the one in which quotation are invited. The Suppliers who has done below listed work are eligible to supply for quotation:

- a. The Suppliers should have successfully executed at least 5 projects of international transport of exotic animal from foreign zoos to zoos in India.
- a) The Suppliers should have successfully executed at least 3 projects of international transport of Grant's Zebra to zoos in India from abroad.

The rights of whether to accept or reject any quotation are reserved with Commissioner, Pune Municipal Corporation.

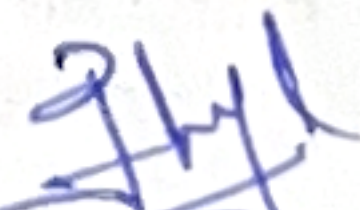
The quotations for the procurement of Grants Zebra should be comparable to Market rates. Inflated rates would not be considered.
